Meeting called to order, 12:12 pm.

Bylaws-

- Election Committee established, to consist of Laura and Cherri
- Ballots need to be made
- Text of bylaw revisions needs to be emailed to all graduate students in the history department
- Due date for ballots needs to be established, ballot box made, arrangements made for Vancouver students
- Motion for approval of bylaws vote by Lesley, seconded by Jackie P.

Registered Student Organization Status for HGSA—

- Need to look into GPSA funding
- HGSA is not a Registered Student Organization (RSO)
- Cynthia reported that we meet all the qualifications for RSO status, just need to register, all of which can be done online
- Cynthia volunteered to conduct RSO organization and registration
- Will cost \$5 to become a GPSA affiliate, free to just register
- RSO's get budget allocations, promotion abilities
- There are 250+ RSO's at WSU, but only 3 GPSA affiliates
- It was considered whether just being an RSO was sufficient, or if GPSA affiliate status should be considered
- Need to consider if we can request money—approve a vote/official email for flier printing, t-shirts, etc.—receiving money will require budget statement
- Need a faculty sponsor for RSO status—agreed that Cherri would approach Dr. Sun, Dr. Sponholtz and Dr. Sanders to inquire if they were interested
- Will need to add a treasurer position to HGSA executive committee/bylaws
- Since this may happen in the summer it was considered that the bylaws may need to be suspended pending a decision in the Fall 2008 semester
- Laura (or the secretary, pending new elections) will act in this position temporarily until the bylaws can be revised and an election held
- PERC- will notify or a vote will be held—something should happen in June
- Rules will be brought up at GPSA 4/7/08
- Laura motioned to approve RSO registration for HGSA as a package, Cherri seconded the motion

Meeting called to order, 12:10 pm.

Women's Candidate Search—

- Jennifer Thigpen recently presented her research on mission women and native queens in the pre-colonial Hawaiian Islands. The general feeling is that this candidate is serious about considering WSU and will be a useful bridge for rebuilding relations between the History and American Studies departments. She will be recommended by the HGSA Faculty Representative.

Unionization—

- Several guests were in attendance at the meeting today to discuss unionization issues and the upcoming Under the Big Tent Debate.
- Debate on the best date for this event—April 1st, or the week of the 14th—18th
- In the Union Reps decide not to participate, what can we do?
 - o Focus on the representation of student workers.
 - Oppose the secrecy—develop a strategy.
 - o Advertise in the Evergreen.
 - O Show accommodation to appear more inclusive, within reason.
 - Registered student organizations are allowed free radio time and up to \$500 from GPSA—this will be looked into.
- For these reasons, it was decided that if no response was received from Union Reps by 3:00 pm., Friday, March 28th, 2008, the debate will be moved back two weeks in order to allow more time for invited participants to make a decision.
- It was noted that the variability between offered assistantships and student positions varies greatly between departments—it makes little sense to try to put a one-size-fits-all organizational contract on all of them.
- It was also noted that some schools, including UC Santa Barbara have chosen to de-certify their unions.
 - o Information on this is available on the web at unionfacts.com, which posts references for all stories.
 - Laura Arata will write a newspaper article for the Evergreen discussing the reasons for decertification at other schools and of the

staff at WSU—when this occurred at WSU, all departments had to do it individually, and currently only Libraries and Maintenance are still unionized.

- o Letters to the Editor of the Evergreen: 250 words or less.
- O Guest Commentaries in the Evergreen: 550 words or less + picture.
 - No Rants.
- It was suggested that a good strategy would be to outline our steps to date—misrepresentation by union people should be noted
- Actual benefits are not stated, and while the UAW website lists benefits for several sectors, academic sectors are not included.
- Our benefits appear to be better than what is offered by UAW
- There is a lack of interest in a union at WSU's Vancouver branch campus at this time.
- It was noted that we already have collective bargaining for WSU via the collective representation through GPSA—we can currently negotiate anytime, as opposed to every 3 years if unionized.
- It was noted that the emergency clause allowing immediate unionization has been stricken from the contract, therefore a vote is required.
 - This vote only requires $1/6^{th}$ of students to vote—a majority of $1/3^{rd}$ of all graduate students
- Cynthia will send out an informational email to all graduate students in the history department.

Bylaws—

- Laura Arata motioned for a vote on the HGSA revised bylaws.
- The motion was seconded by Amanda Van Lanen.
- The motion was unanimously passed in favor of sending the bylaw revisions to a general vote of the HGSA body.
