- If accepted, the GSC unanimously agreed that it should request that the department assume the fee for each student's first attempt
- The GSC also discussed the possibility of allowing students and their major professor decide whether or not to conduct the exam in-house
- The HGSA voted 5-2, with 2 abstaining, to keep the exam process as is—most students were concerned with the loss of the student-professor relationship, the \$30 fee, and the standards of the exam if it were to be handed over to Foreign Languages
- In a second vote regarding whether students and their mentor should decide the process, the **HGSA** voted 4-3, with 2 abstaining, against it
- One Ph.D. student proposed that HGSA request the GSC to add some sort of computer proficiency to the language requirement, as, for many, such a proficiency is more valuable to their intended profession than a knowledge of a foreign language and many departments have such an option
- The HGSA agreed and the issue will be aired at the next GSC meeting

3) GPSA Report:

- A) GPSA has made graduate insurance a priority—still shopping around to find the best deal
- B) GPSA has formed a committee to pursue its unionization agenda
  - Seeking to have a vote on whether graduate students should join the "Students for Favorable Working Conditions" movement
  - Seeks to implement the UW model
  - HGSA resoundingly voted to oppose such measures if introduced to GPSA

4) Miscellaneous:

A) Kaag requested the GPSA senators to propose that the GPSA encourage the administration to be proactive in aiding military reserve students in putting their academic affairs in order
